Agrichemical residue analyses

- Our agrichemical residue analyses are performed by Agrifood Technology Pty Ltd, Werribee, Victoria. Australia.
- Agrifood Technology is accredited by the National Association of Testing Authorities (NATA) and is ISO:9001 certified.
- Agrifood Technology test for 307 Agrichemicals. The complete list of results is available upon request.
- As per the Barth-Haas Quality Control Guarantee for crop 2024 HPA analysed at least 1 sample for every 40 tonnes of hops harvested. All varieties and growing regions were represented in the samples tested.
- For crop 2024 we tested 42 samples.

Heavy metal analyses

- Our heavy metal analyses are performed by the "Nata" (National Association of Testing Authorities) accredited laboratory, Analytical Services Tasmania at the University of Tasmania.
- We analyse for Arsenic, Lead, Cadmium, Mercury, Nickel, Copper, Iron, Selenium, Chromium, and Cobalt.
- 20 samples are tested representing each growing region and variety.
